In February, the air district sent out all 8 applications received. Two applications did not meet requirements, the other three applications required more information to move forward.	ICAPCD	3/10/24
How much money is remaining in the total budget for future projects? Is there an orientation for the remaining funds allocated for this project type?	The total budget was \$25,373,247.11. The remaining budget is \$7,339,962.55. The three paving proposals would cost nearly \$4.3 million with about \$3 million dollars additional funds remaining if the three paving projects get approved.
