FUNDING ALLOCATION

\$25.3 MILLION IN STATE FUNDING


Since October 2019, Assembly Bill 617 has allocated \$25.3 million in funding to the communities of Calexico, El Centro, and Heber. Through the collaborative efforts of the Community Steering Committee and the Air District, around \$9.9 million has been directed towards paving projects at school sites and local townships. Approximately \$8.8 million has been allocated to development of Electric Vehicle Infrastructure for school districts and public services. And, approximately \$3.3 million has been designated for projects related to Urban Greening, School Bus Replacements, and School Air Filtration Systems. A number of these projects have been completed and are being evaluated by the District to assess their total emission reduction impact.

Some current projects in progress are:

- Paving at Calexico High School
- EV Infrastructure at McCabe School District
- Paving at Center for Employment El Centro
- School Bus at Heber School District
- Paving at Heber Townsite Phase II

In January, the Community Steering Committee will discuss strategies to finalize the remaining funding (approximately \$4.03 million). The goal is to allocate the funds by the close of the 2024-25 fiscal year. The committee will also work towards transitioning the charter into the closure of the funding provided under Assembly Bill 617 for these specific communities.

EV INFRASTRUCTURE MEADOWS UNION SCHOOL

The Meadows Union School District was awarded approximately \$1.2 million in funding to install four (4) electrical vehicle chargers on campus. The District aims to implement the chargers by February 2025 to power their recently acquired fleet of four (4) electric buses through California's HVIP: Hybrid and Zero-Emission Truck and Bus Voucher Incentive Project. The project is being carried out by Site Logiq.
